Study leave / compensation leave from school:

Childcare on days when there is study leave or compensation leave at the school is possible. The rates that apply to your package apply to these hours.

Flexible childcare:

It is possible to make use of flexible childcare. It is not guaranteed that there is always childcare possible. This depends on the employee-child ratio on that particular day. The price per hour for flexible childcare is **€ 11,02**.

(*) Explanation 48 weeks package:

In choosing this package, your child is entitled to childcare in the school week and in 8 holiday weeks on the agreed days and childcare hours.

The holiday season in which you do not use the childcare facility can be flexibly planned.

- Weeks that you do not need childcare in the summer holidays, we would like to hear before April. 1st
- Weeks that you do not need childcare during other school holidays we like to hear 2 weeks in advance.

Days that are not used at the end of the year can not be taken to the next year.

Kinderopvangtoeslag/(Childcare allowance):

In 2024 the amount from the government for which you can get reimbursement is **€ 8,30***.

In the Childcare Allowance Table 2024 you can see what percentage you can get back through the childcare allowance. This will be available on www.rijksoverheid.nl after the final adoption of the KOT2024. You can also make a test calculation yourself via [a trial calculation](#).

PAY ATTENTION: The first child is the child with the most childcare hours per month.

*) During the recent discussion of the 2024 Budget Memorandum, the House of Representatives adopted the amendment adopted to additionally increase the KOT2024, in connection with the structural lag in indexation of it in recent years. Formally, the National Budget and the associated tax plans are still to be approved by the Senate. Experience shows that this almost always happens.

After approval, the adjusted childcare allowance for after-school care will become **€9.12** in 2024.

As soon as the Senate (before the end of this year at the latest) has approved the budget and the the adjusted KOT2024 is final, we will let you know.
